MY SWEDE-MALAYSIAN DALA CREATIVE ART CONTEST

Terms and Conditions for All Participants

Ikano Corporation Sdn Bhd. with corporate identity number 457554-H and registered office at 2 Jalan PJU 7/2, Mutiara Damansara, 47800 Petaling Jaya, Selangor, Malaysia ("IPC") is organizing the My Swede-Malaysian DALA Creative Art Contest.

Entry requirements

1. The My Swede-Malaysian DALA Creative Art Contest will be open online in Malaysia between the following dates: 11 March 2022 and 10 April 2022. This contest is open to children of 12 years old and below to participate. IPC employees and their immediate families are excluded from the contest.
2. No purchase or any other fee payment is necessary in order to participate in the contest.
3. All those intending to participate in the contest must have the consent of their parent or guardian to do so. Consent is presumed if the parent or guardian has signed these Terms and Conditions for All Participants.
4. Only one entry can be made by each individual child. A child participant cannot be assisted in his/her participation by parent, guardian or any third party. Any such entries will be disqualified. Late or incomplete entries will also be disqualified.
5. Each participant's drawing must be completed on A4 or letter sized white paper. Each participant and his/her parent or guardian must indicate on the back of the design the following information:
 - i. First name and age of the participant; and
 - ii. First and last name, contact information and the IPC Tack Club membership number (if any) of the parent or guardian.

How to participate

6. IPC will invite all participants to enter the contest by submitting a drawing online (or offline to our i-Counter, Level G of IPC Shopping Centre if submission via online is not possible). The drawing template can be downloaded at ipc.com.my/MySwedeDALA and artwork can be submitted to ipc@ikano.asia.
7. A short list of preliminary drawings ("finalists") will be selected by the IPC Marketing Department and published on IPC Shopping Centre's Facebook page after the closing date of the contest for the public to give votes through "likes" on their preferred drawings which accounts for 20% of the overall scores.
8. The same short list of preliminary drawings ("finalists") will also be put forward by the IPC Marketing Department to the judging panel consisting of the management team at IPC after the closing date of the contest which accounts for 80% of the overall scores.
9. IPC will select 7 drawings ("winners") based on the total scores taken from the judging panel and public votes. IPC will not disclose the finalists and/or winners' total scores.
10. Criteria for electing the winners are based on creativity, originality, clarity to theme, presentation and possibility of drawings to be replicated and painted on the DALA horse sculptures.

Prizes

11. All entries will receive an e-certificate. The e-certificates will be sent to the parent or guardian via e-mail within 5 days upon receiving the contest entries (drawings).
12. There will be 7 winners in total and each will receive:
 - i. IPC Raya shopping e-vouchers worth RM100 (to be collected and used during IPC Raya campaign between 7 April to 15 May 2022).
 - ii. One (1) acknowledgement metal plaque engraved with the child's (winner's) first name, age, city/town and state which will be permanently secured onto the floor, next to the DALA horse sculpture at the al-fresco area of IPC Shopping Centre (public display use) that will be replicated and painted by IPC's appointed artist based on the winners' drawings.
 - iii. One (1) IKEA gift set worth RM250 (sponsored by IKEA) that contains:
 - One (1) RM100 IKEA gift card
 - One (1) MÅLA easel
 - One (1) MÅLA mixed colours paint set
 - One (1) MÅLA drawing paper roll
 - iv. One (1) Sistema 450ml sandwich box (sponsored by POPULAR).
13. All prizes are non-negotiable, non-transferable and non-refundable. No cash or credit alternatives will be given in exchange for the whole or any part of the prizes. IPC reserves the right to substitute the prize with another prize or equivalent value.

IPC reserves the absolute right to select an alternate winner and award the prize to another participant in the event that IPC have reasonable grounds to believe that a participant has acted in a way which is inconsistent and contrary with these Terms and Conditions for All Participants or has acted in a way which IPC considers to be inappropriate, unlawful or offensive.
15. The winners will be notified by e-mail and/or phone by IPC, including the collection period of the prizes.
16. IPC will select the 7 winners. This decision is final. No correspondence on any matter concerning the election of the winners will be entered into with any parent, guardian and/or participant.

Liability and permissions

Personal data

21. In order to enter into this contest, participants and their parents or guardians will be required to provide certain personal data. The parent or guardian is aware of that the child's first name, age, city/town and state, if selected as winner, will be published online e.g. webpages and social media as well as in printed media. Publishing online further means that IPC will not be in complete control over the personal data as IPC will not be able to prevent any individual from downloading and spreading the personal data.

Intellectual Property Rights

23. IPC would like to base new DALA horse designs on the contest entries (drawings) from the 7 winners and paint the DALA horse sculptures from these designs with the purpose to display them at the al-fresco area of IPC Shopping Centre (public display use).
24. All contest entries must be the original work of the participant. Any intellectual property rights including but not limited to copyright and design rights in the drawings and the description of the creative process provided by participants, in the winning entries, and in the painted DALA horse sculptures, are transferred to and shall belong to IPC from the point at which the contest entries are provided to IPC. IPC has the right to alter and adapt the original work in order to paint the DALA horse sculptures. The original work and any alterations and adaptations may be used by any IPC affiliate in marketing material irrespective of medium and form.
25. The participant will only be named by first name, if named at all, in connection with marketing. Any right to be named in connection with the painting of the DALA horse sculptures is hereby waived.
26. The 7 winners whose drawings are purposed for public display use will have no rights in the designs or receive any remuneration, reward or other benefit as a result of the use of their design other than the prizes provided for in these Terms and Conditions for All Participants. IPC will not develop products based on any of the nonwinners in the contest. If any of the 7 designs is not possible to produce, IPC reserves the right to remove this product and exchange it.

Governing Law

27. The My Swede-Malaysian DALA Creative Art Contest and any dispute or claim arising out of or in connection with it, shall be governed and construed in accordance with laws of Malaysia.
